EDEN'S STORY



Eden, now seven, was just 14-months-old when she was diagnosed with neuroblastoma, a rare and aggressive type of cancer. For weeks, Eden had been unwell, catching colds and viruses and going back and forth to her GP constantly. Eden's local hospital later sent the family in an ambulance to Great Ormond Street Hospital where Eden was diagnosed with neuroblastoma - a solid mass tumour in her abdomen, which was already 15cm long when it was found.

Eden stayed on Giraffe Ward for three weeks, where she was treated with chemotherapy straight away. After about a year of chemotherapy, doctors at GOSH then recommended that Eden should have immunotherapy - a treatment which uses the body's own immune system to attack cancer cells. After months of treatment and anxious waiting, Eden and her family received good news that her neuroblastoma was under control. Eden will continue to have regular check-ups at GOSH every three months as she gets older.

Eden's mum Emma is here with us this evening to share their story of Eden's diagnosis, the gruelling chemotherapy and immunotherapy treatment and Eden's incredible strength in recovery, which has come at a cost - both physically and mentally, not only for Eden but also for her loved ones.
